On that note, The SLUTS, aka the St. Louis Costumers Guild has been very active lately as usual.


Just a few things we have been up to:

Kawa Kon (March 12-14, 2010)

Kawa Kon is an annual anime convention held in St. Louis, Missouri at the Crowne Plaza Clayton. This year's theme was "matsuri" (festival), emphasizing Japanese culture and arts, as well as anime, gaming, and cosplay. The hallways were full of colorful cosplayers, as attendees in costume receive a \$5 discount upon registering for the convention.

The schedule for the weekend was chock full of exciting events and panels such as a Bunraku (puppetry) performance, taiko drumming, tea ceremonies, and even a kimono fashion show (presented by Three Rivers Okiya, St. Louis' premier geisha troupe). In "Iron Kaiju", three teams rushed to build Godzilla-like monsters out of boxes, fabric, and other such junk. A more relaxing event was the "Host Party", where con-goers were treated to conversation, games, and snacks by a group of talented cosplayers. The weekend was rounded out with game shows, fan panels, tournaments, and a rave. Kawa Kon's masquerade is perhaps the most anticipated event of the weekend, showcasing some of the best workmanship and presentations by cosplayers all over the Midwest. With fully professional sound and lighting, masquerade entrants also had the option of projecting a video or still backdrop behind them to interact with. The St. Louis Costumers Guild also helped out with the masquerade as judges and den moms. Numerous awards were given out for the excellent costumes and presentations. The masquerade could not be nearly as wonderful as it is each year without the generous time commitments of the SLCG.

INTERNATIONAL COSTUMERS' GUILD STANDARDS OF PRACTICE FOR COSTUME COMPETITIONS REQUESTING ICG RECOGNITION AS "INTERNATIONAL"

The document ICG Guidelines: Ensuring Fair Competition notes that the International Costumers Guild recognizes certain contests as "International Competitions", but that standards for recognizing additional events with that status are not within the scope of those fairness guidelines. At the time of this writing, the events so recognized are WorldCon, Costume-Con and Anime North.

This document delineates standards intended to establish the guidelines and procedures by which the ICG may so accredit an event as an "International Competition as described in the ICG Guidelines: Ensuring Fair Competition".

1. A Costume Competition will be considered for ICG accreditation as an "international competition" at the request of its owning organization, said request to be addressed to the ICG Corresponding Secretary.

2. Each request will be considered on a case-by-case basis. The ICG President (or President's designee) will appoint an accreditation committee to review the request and present a recommendation to the ICG BOD for final approval/denial. The Board may choose to have the general membership ratify such decisions.

3. The Costume Competition and Event under consideration should adhere to the following standards:

1. Costume Competition at the Event must include judged competition of entrant-built costumes. Entrant-built means that at least one member of an entry had an active creative hand in the construction/ assembly of their costume(s).

2. Judging and awards should focus on costumes, their design and implementation rather than performance. (Presenting of awards for performance does not disqualify a competition from consideration, but a significant set of awards focused on costume must be presented).

3. Competition rules must be explicitly based on the document ICG Guidelines: Ensuring Fair Competition.

4. The Competition demonstrates a general respect of and support for costume, costumers and costuming.

5. The Competition allows and encourages participation by entrants from outside the host country of the Competition.

6. The ICG may choose at any time to revisit its accreditation of a Competition as an "International Competition". Should such review disclose that the event no longer meets these standards, such accreditation will be revoked.

G-Anime

This past February, lost in a small city in Canada, there was a small anime convention: G-Anime. In the con's second year and with an attendance of 1046 people, we were able to get enough people for a decent costuming/cosplay track. All of the panels on the costuming/cosplay track were given by people with passion for costuming or cosplaying and most of them are national masters.

For those of you costumers who are confused by the difference between costuming and cosplay, many cosplayers like to be extremely specific with their terms. Cosplay is a term specifically used when reproducing costumes based out of an anime (mostly Japanese) or video game. Costuming, on the other hand, is used more generally and includes cosplay under its umbrella.

Our cosplay track had a panel on historical costuming in anime and how to do and use historical research when doing an anime costume, basic makeup for stage performance, how to built a mascot or furry, an informative panel on Japanese garments, how to make a duck tape dummy, etc.

Even if our audience consisted mostly of 18-year-olds, they have a lot of potential and are always interested in knowing more about the cosplay world.

The masquerade was run following the ICG guidelines and was judged by Maral Agnerian, Eric Brine, Geneviève Levasseur and Mélissa Langlois. Some of you may recognise some of these names as notable people from the Canadian Chapter.
